**RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF FOOD SUPPLIES FOR USE OF BATANGAS CITY GOVERNMENT**

**WHEREAS**, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, Batangas City Government intends to procure Food Supplies (Wet and Dry) charged under General Fund (Cash Advance) to be served for frontliners assigned in and Covid-19 patients currently confined in various Temporary Health Facilities of Batangas City Government and those isolated/quarantined in their homes as requested by BCIMT-Logistic Section/Kitchen Brigade;

**WHEREAS**, Batangas City, under Alert Level I as of this time and there is an utmost need to procure goods hereunder listed for the health and nourishment of patients confined at the Temporary Health/Isolation Facility, their respective homes and frontliners assigned in the conduct of Covid19 programs and activities;

**WHEREAS**, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services:
