**"BAC RESOLUTION NO. 2022-227"**

**RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF SUBSCRIPTION OF VARIOUS JOURNALS THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY BATANGAS CITY LIBRARY AND INFORMATION CENTER**

**WHEREAS**, the Batangas City Government intends to procure Subscription of Various Journals and Magazines with an Obligated Purchase Request No. 200-2022-03-002783 charged under General Fund dated March 10, 2022 with an Approved Budget for the Contract (ABC) amounting to Sixty Eight Thousand Two Hundred Fourteen Pesos (Php68,214.00) for use of Batangas City Library and Information Center;

**WHEREAS**, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

**WHEREAS**, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

**WHEREAS**, on May 11, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotations (RFQ's) thru the Philippine Government Electronic Procurement System (Philgeps) for the procurement of the above mentioned project;

**WHEREAS**, before the deadline of submission of quotation on May 16, 2022, the following suppliers submitted their quotations, to wit;

1. EESM Bookstore
2. Lorimar Publishing Inc.
3. Litera Trading

**WHEREAS**, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned suppliers sufficiently complied with all the requirements needed which resulted to the following:





RESOLVED and APPROVED unanimously, at Batangas City, this 16<sup>th</sup> of May, 2022.




