"BAC RESOLUTION NO. 2022-259

RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF TOKEN THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY DEPED, DIVISION OF BATANGAS CITY

WHEREAS, the Batangas City Government intends to procure Token, with an Obligated Purchase Request No. 200-2022-05-000045 charged under General Fund dated May 13, 2022 with an Approved Budget for the Contract (ABC) amounting to Eighty Thousand Pesos (Php80,000.00), for the Layout Artist, Proofreader/Grammarians and Reviewers as requested by DepEd, Division of Batangas City;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

WHEREAS, on May 05, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotations (RFQ's) thru the Batangas City Website (www.batangascity.gov.ph) for the procurement of the above mentioned project;

WHEREAS, BATANGAS CITIMART SHOP-ON INC. with business address located at Rizal Avenue, Pob. 16, Batangas City, is the lone supplier submitted its quotation;

WHEREAS, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned suppliers sufficiently complied with all the requirements needed which resulted to the following:


WHEREAS, the price offered by **BATANGAS CITIMART SHOP-ON INC.** was found to be reasonable and advantageous to the City Government, if accepted;


