## RECOMMENDING AWARD OF CONTRACT FOR THE TERMITE CONTROL SERVICES THROUGH NEGOTIATED PROCUREMENT (EMERGENCY CASES) AS REQUESTED BY GENERAL SERVICES DEPARTMENT, BATANGAS CITY

WHEREAS, the Batangas City Government intends to procure One (1) Termite Control Services with an Obligated Purchase Request No. 200-2022-05-004828 charged against General Fund dated May 11, 2022 with Approved Budget for the Contract (ABC) amounting to Thirty Thousand Pesos (Php30,000.00) as requested by General Services Department;

WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained;

WHEREAS, Negotiated Procurement under Emergency Cases may be resorted in case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other cases where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities;

WHEREAS, as per letter from the General Services Department, the requisitioning office thereof, the need for the treatment is immediate as it caused significant damages in the Office of the BAC Secretariat-Technical Working Group for the Procurement of Goods and Services and Supply and Materials Section II;

**WHEREAS**, the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of RA 9184, under Section 53.2 (Emergency Cases) as per approved authority;

WHEREAS, it appearing that the price offered by MAPECON PHILIPPINES INC. with business address located at 251 National Highway, Brgy. Aguila, San Jose, Batangas was found to be reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HoPE for the APPROVAL of the AWARD and ACCEPT the offer made by **MAPECON PHILIPPINES INC.** in the grand total amount of P30,000.00 to wit:
