**RECOMMENDING AWARD OF CONTRACT FOR THE RENTAL OF VANS FOR THE CONDUCT OF CITY  
TREASURER'S OFFICE TEAM BUILDING AND PLANNING WORKSHOP THROUGH NEGOTIATED  
PROCUREMENT (SMALL VALUE PROCUREMENT)**

**WHEREAS**, the Batangas City Government intends to procure Rental of Seven (7) Vans with an Obligated Purchase Request No. 200-2022-06-005937 charged under General Fund dated June 06, 2022 with an Approved Budget for the Contract (ABC) amounting to One Hundred Forty Thousand Pesos (Php140,000.00) for the conduct of Team Building and Planning Workshop of City Treasurer's Office;

**WHEREAS**, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

**WHEREAS**, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

**WHEREAS**, on June 15, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotation (RFQ's) thru the Philippine Government Electronic Procurement System (Philgeps) for the procurement of the above mentioned project;

**WHEREAS**, before the deadline of submission of quotation on June 20, 2022, only **LRJN TOURIST TRANSPORT SERVICE** with business address located at Sirang Lupa, Batangas City submitted its quotation;

**WHEREAS**, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned suppliers sufficiently complied with the submission of all requirements needed which resulted to the following:
