### RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD, VENUE AND ACCOMMODATION THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE

**WHEREAS**, the Batangas City Government intends to procure Food, Venue and Accommodation with an Obligated Purchase Request No. 200-2022-05-005287 charged under General Fund dated May 18, 2022 with an Approved Budget for the Contract (ABC) amounting to Two Hundred Eighty Thousand Pesos (Php 280,000.00) for the conduct of Ka-BRAD Regular Monthly Evaluation and Assessment as requested by City Environment and Natural Resources Office;

**WHEREAS**, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

**WHEREAS**, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

**WHEREAS**, on June 09, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotation (RFQ's) thru the Philippine Government Electronic Procurement System (Philgeps) for the procurement of the above mentioned project;

**WHEREAS**, before the deadline of submission of quotation on June 21, 2022, only **PLAYA MONTANA BEACH RESORT** with business address located at Sitio Malao, Pagkilatan, Batangas City submitted its quotation;


**WHEREAS**, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned supplier sufficiently complied with all the requirements needed which resulted to the following:




**WHEREAS**, the price offered by **PLAYA MONTANA BEACH RESORT** was found to be reasonable and advantageous to the City Government, if accepted;



RESOLVED and APPROVED unanimously, at Batangas City, this 23<sup>rd</sup> of June, 2022.




