"BAC RESOLUTION NO. 2022-298

RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF AIRFARE, FOOD, HOTEL ACCOMMODATION AND OTHER INCIDENTAL EXPENSES FOR THE CONDUCT OF THREE-DAY-LAKBAY ARAL OF ALL DIVISION CHIEFS UNDER THE OFFICE OF THE CITY MAYOR THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT)

WHEREAS, the Batangas City Government intends to procure Airfare, Food, Hotel Accommodation and Other Incidental Expenses with an Obligated Purchase Request No. 200-2022-06-006567 charged under General Fund dated June 16, 2022 with an Approved Budget for the Contract (ABC) amounting to Three Forty Thousand Six Hundred Thirty Five Pesos (Php349,635.00) for the conduct of three-day-Lakbay Aral of all Division Chiefs under the Office of the City Mayor, Batangas City;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

WHEREAS, on June 17, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotation (RFQ's) thru the Philippine Government Electronic Procurement System (Philgeps) for the procurement of the above mentioned project;

WHEREAS, before the deadline of submission of quotation on June 20, 2022, only **BALI-GEM TOURS & TRAVEL** with business address located at 58 Sumulong Highway, Mayamot, Antipolo City submitted its quotation;

WHEREAS, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned suppliers sufficiently complied with all the requirements needed which resulted to the following:
