WHEREAS, the Batangas City Government intends to procure Token, with an Obligated Purchase Request No. 200-2022-06-000064 charged under General Fund dated June 06, 2022 with an Approved Budget for the Contract (ABC) amounting to Forty Two Thousand Pesos (Php42,000.00), for the conduct of Training/Workshop on Training Quantitative and Qualitative Research in Education CUM Updates on Research Guidelines and Policies as requested by DepEd, Division of Batangas City;
