“BAC RESOLUTION NO. 2023-357”

RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF MEALS AND ACCOMMODATION THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY THE OFFICE OF THE SK FEDERATION PRESIDENT, BATANGAS CITY

WHEREAS, the Batangas City Government intends to procure Meals and Accommodation with an Obligated Purchase Request No. 200-2023-03-004119 charged under General Fund dated March 16, 2023 with an Approved Budget for the Contract (ABC) amounting to Three Hundred Thousand Pesos (Php300,000.00) for the conduct of City Youth Development Council Capacity Development Seminar and Teambuilding Activity as requested by the Office of the SK Federation President, Batangas City;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the “Government Procurement Reform Act” provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

WHEREAS, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotation (RFQ's) thru the Philippine Government Electronic Procurement System (Philgeps) for the procurement of the above mentioned project;

WHEREAS, before the deadline of submission of quotation, only **ZIRCONSTAR PROPERTY RENTALS** with business address located at Ms. Philippines St. Poblacion 10, Batangas City submitted its quotation;

WHEREAS, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned supplier sufficiently complied with all the requirements needed which resulted to the following:

WHEREAS, the price offered by **ZIRCONSTAR PROPERTY RENTALS** was found to be reasonable and advantageous to the City Government, if accepted;




