WHEREAS, Batangas City Government intends to procure One (1) year Organizational Validated Standard SSL with an approved Purchase Request (PR) Nos. 16049 charged under General Fund dated August 09, 2021 as requested by CMO-Information Technology Services Office;

WHEREAS, the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) as per approved authority. Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, **Direct Contracting**, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained;
