RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF TOKEN THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY DEPED, DIVISION OF BATANGAS CITY

WHEREAS, the Batangas City Government intends to procure Token, with an Obligated Purchase Request No. 200-2022-05-000093 charged under General Fund dated July 14, 2022 with an Approved Budget for the Contract (ABC) amounting to Four Thousand Pesos (Php4,000.00), for the conduct of Division Orientation on the Pilot Implementation of Alternative Learning System (ALS) Senior High School Program as requested by DepEd, Division of Batangas City;

WHEREAS, on July 22, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotations (RFQ's) thru the Batangas City Website (www.batangascity.gov.ph) for the procurement of the above mentioned project;

WHEREAS, BATANGAS CITIMART SHOP-ON INC. with business address located at <u>Rizal</u> Avenue, Pob. 16, Batangas City, is the lone supplier submitted its quotation;

WHEREAS, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned suppliers sufficiently complied with all the requirements needed which resulted to the following:
