"BAC RESOLUTION NO. 2022-377-A

RECOMMENDING AWARD OF CONTRACT FOR THE DRY CLEANING OF CAPS AND GOWNS THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY COLEGIO NG LUNGSOD NG BATANGAS

WHEREAS, the Batangas City Government intends to procure Dry Cleaning of 10 sets cap and gown with an Obligated Purchase Request No. 200-2022-05-000331 charged under General Fund dated July 12, 2022 with an Approved Budget for the Contract (ABC) amounting to Seven Thousand Five Hundred Pesos (Php7,500.00), as requested by Colegio ng Lungsod ng Batangas;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

WHEREAS, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotations (RFQ's) thru the Batangas City Website (www.batangascity.gov.ph) for the procurement of the above mentioned project;

WHEREAS, CARMEL LAUNDRY SHOP with business address located at Strawberry St., Greenwoods Subd., Pallocan Silangan, Batangas City, is the lone supplier submitted its quotation;






