"BAC RESOLUTION NO. 2022-232

RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF FOOD AND VENUE THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY DEPED, DIVISION OF BATANGAS CITY

WHEREAS, the Batangas City Government intends to procure Food and Venue with an Obligated Purchase Request No. 200-2022-05-000094 charged under General Fund dated July 14, 2022 with an Approved Budget for the Contract (ABC) amounting to One Hundred Thirty Five Thousand Pesos (Php135,000.00) for the conduct of 5-day-Seminar Workshop of IPED Orthography Development Plan as requested by DepEd, Division of Batangas City;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

WHEREAS, on July 25, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotation (RFQ's) thru the Philippine Government Electronic Procurement System (Philgeps) for the procurement of the above mentioned project;

WHEREAS, before the deadline of submission of quotation on July 28, 2022, the following suppliers submitted their quotations, to wit;

1. Solana Event Center Co.
2. PCK Trade & Realty Corp.
3. Playa Montana Beach Resort






