WHEREAS, the Batangas City Government intends to procure 3,000 pads (150,000 sets) of Accountable Form 56 (Personalized) with an Obligated Purchase Request 200-2022-08-009190 dated August 15, 2022 charged under General Fund with Approved Budget for the Contract (ABC) amounting to Six Hundred Six Thousand Pesos (Php606,000.00) as requested by City Treasurer's Office;


