**RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-AGENCY TO AGENCY AS MODE OF PROCUREMENT FOR THE PURCHASE OF ACCOUNTABLE FORM NO. 51 AS REQUESTED BY CITY TREASURER'S OFFICE**

**WHEREAS**, the Batangas City Government intends to procure 6,000 pads (300,000 sets) of Accountable Form 51 (Customized) with an Obligated Purchase Request 200-2022-08-009719 dated August 25, 2022 charged under General Fund with Approved Budget for the Contract (ABC) amounting to One Million Four Hundred Seven Thousand Pesos (Php1,407,000.00) as requested by City Treasurer's Office;

**WHEREAS**, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provision of RA 9184 Section 53.5 (Negotiated Procurement-Agency to Agency) citing that the procurement of infrastructure projects, consulting services and goods from another agency of the Government of the Philippines can be made directly to a government entity;

**WHEREAS**, it appearing that the price offered by **NATIONAL PRINTING OFFICE** with business address located at EDSA cor. NIA North Road, Diliman, Quezon City was found to be the most reasonable and advantageous to the City Government, if accepted;
