WHEREAS, the requirements under Section 51 of the Government Procurement Reform Act (RA 9184) and its Implementing Rules and Regulations have been complied with; a.) unit prices of the repeat order must be the same as or lower than those in the original contract, provided that the price is still most advantageous; b.) the repeat order will not result in splitting of contracts, requisition, or purchase orders; c.) the repeat order shall be availed of only within six (6) months from the date of the Notice to Proceed arising from the original contract, provided that there has been a partial delivery, inspection and acceptance of the good within the same six-month period, and; d.) the repeat order does not exceed twenty-five percent (25%) of the quantity of each item in the original contract;
