"BAC RESOLUTION NO. 2022-443

**WHEREAS**, the Batangas City Government intends to procure Snacks with an Obligated Purchase Request No. 200-2022-08-009716 charged under General Fund dated August 25, 2022 with an Approved Budget for the Contract (ABC) amounting to Eight Thousand Seventy Pesos (Php8,070.00) for the conduct of 3<sup>rd</sup> Quarterly Meeting of the City Council for the Protection of Children (CCPC) as requested by City Planning and Development Office;

**WHEREAS**, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of **Section 51 of the IRR of RA 9184 (Repeat Order)** which pertains to the procurement of goods from the previous winning bidder, whenever there is a need to replenish goods procured under a contract previously awarded through Competitive Bidding;

**WHEREAS**, after having considered the previous procurement of Meals and Snacks as requested by Sangguniang Panglungsod, Batangas City, which was Recommended for Acceptance and Approval by the Bids and Awards Committee in its *Resolution No. 2022-135* dated March 16, 2022 with corresponding *Purchase Order No. 161* dated March 17, 2022, copy attached, in favor of **GRANDIOSE FOOD SERVICES** with address located at D. Silang St., cor. P. Burgos St., Pob. 14, Batangas City;


**WHEREAS**, the requirements under Section 51 of the Government Procurement Reform Act (RA 9184) and its Implementing Rules and Regulations have been complied with; a.) unit prices of the repeat order must be the same as or lower than those in the original contract, provided that the price is still most advantageous; b.) the repeat order will not result in splitting of contracts, requisition, or purchase orders; c.) the repeat order shall be availed of only within six (6) months from the date of the Notice to Proceed arising from the original contract, provided that there has been a partial delivery, inspection and acceptance of the good within the same six-month period, and; d.) the repeat order does not exceed twenty-five percent (25%) of the quantity of each item in the original contract;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND for the APPROVAL to place a **REPEAT ORDER** of the same item from the same business entity under the same terms and conditions contained in the aforesaid Purchase Order in accordance with Article XVI, Section 51 of Republic Act No. 9184 (Government Procurement Reform Act), to wit:






