"BAC RESOLUTION NO. 2022-490

RECOMMENDING AWARD OF CONTRACT FOR THE RENTAL OF BUS THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) FOR USE OF THE BATANGAS CITY GOVERNMENT

WHEREAS, the Batangas City Government intends to procure Bus Hire with an Obligated Purchase Request No. 200-2022-08-008734 charged under General Fund dated August 25, 2022 with an Approved Budget for the Contract (ABC) amounting to One Hundred Ten Thousand Pesos (Php 110,000.00) for use of Batangas City Government;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

WHEREAS, on July 26, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotation (RFQ's) thru the Philippine Government Electronic Procurement System (Philgeps) for the procurement of the above mentioned project;

WHEREAS, before the deadline of submission of quotation, only **CERES TRANSPORT INC.** with business address located at Diversion Rd., Alangilan, Batangas submitted its quotation;






WHEREAS, the price offered by **CERES TRANSPORT INC.** was found to be reasonable and advantageous to the City Government, if accepted;




