**"BAC RESOLUTION NO. 2022-483**

**RECOMMENDING AWARD OF CONTRACT FOR THE PROCUREMENT OF ROOM ACCOMMODATION THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY THE OFFICE OF THE CITY VETERINARY AND AGRICULTURAL SERVICES**

**WHEREAS**, the Batangas City Government intends to procure Room Accommodation including Meals with an Obligated Purchase Request No. 200-2022-09-010027 charged under General Fund dated September 05, 2022 with an Approved Budget for the Contract (ABC) amounting to Forty Four Thousand Five Hundred Pesos (Php44,500.00) for the conduct of Gender Development Seminar of the Office of the City Veterinary and Agricultural Services;

**WHEREAS**, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

**WHEREAS**, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) **citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;**

**WHEREAS**, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotations (RFQ's) thru the Batangas City Website ([www.batangascity.gov.ph](http://www.batangascity.gov.ph)) for the procurement of the above mentioned project;

**WHEREAS**, only **LA SUEÑA BRISA BEACH RESORT & EVENTS PLACE** with business address located at Nonong Casto, Lemery, Batangas submitted its quotation;

**WHEREAS**, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned suppliers sufficiently complied with all the requirements needed which resulted to the following:
