

WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, as per IATF Resolution, Batangas City is still under the General Community Quarantine with heightened restrictions;

WHEREAS, the Approved Purchase Request (PR) No. 16709, charged under General Fund for the **Rental of Motor Vehicles amounting to Four Million Eighty Thousand Pesos (Php4,080,000.00)** as requested by the Batangas City Incident Management Team-Logistics Section to be used by the Contact tracing unit, monitoring of different establishment and information dissemination campaign by the Public Information Office and other members of BCIMT in response to the fight against COVID-19 was endorsed to the Bids and Awards Committee (BAC);

WHEREAS, to augment the existing Motor Vehicles owned by the City Government for the conduct of these activities, the BCIMT thru the Logistics Section deemed it necessary to request the rental of these motor vehicles, including drivers and incidental expenses to be incurred in relation thereto.

WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services;

WHEREAS, it appearing that the price offered by **D. DIMAANDAL CAR CARE CENTER** with business address located at Kumintang Ibaba, Batangas City was found to be the most reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND for the APPROVAL of the AWARD and ACCEPT the offer made by **D. DIMAANDAL CAR CARE CENTER** in the grand total amount of 4,080,000.00 to wit;
