WHEREAS,	Section 15 Article II of the 1987 Constitution avers that the State shall protect

WHEREAS,	as per IATF Resolution, Batangas City is still under the General Community
	Quarantine with heightened restrictions;

WHEREAS,	the Approved Purchase Request (PR) No. 16851 charged under General Fund for
	the Supply and Delivery of PPE Cover All with Head and Shoe Cover amounting
	to One Hundred Seventy Five Thousand Pesos (Php175,000.00) as requested by
	BCIMT Logistics Section was indorsed to the Bids and Awards Committee (BAC);

	responsibilities of the frontliners of the Batangas City Incident Management
	Team-Covid19:

	effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is

	the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) in case of
	imminent danger to life or property during state of calamity, to save and to
	prevent damage to or loss of life or property, or to restore vital public services;
