RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF PREPAID LOAD CARD AS REQUESTED BY EBD MT-REFERRAL TEAM

- WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and **instill health consciousness among them;**
- WHEREAS, as per IATF Resolution, Batangas City is still under the General Community Quarantine with heightened restrictions;
- WHEREAS, the Approved Purchase Request (PR) No. 16702 charged under General Fund for the **Supply and Delivery of Prepaid Load Card amounting to Five Thousand Three Hundred Pesos (Php5,300.00)** as requested by EBD-MT Referral Team was indorsed to the Bids and Awards Committee (BAC);
- WHEREAS, there is an utmost need to procure Prepaid Load Cards in the dispense of duties and responsibilities re: Covid19 programs and activities of the frontliners of the EBD-MT Referral Team;
- WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) **in case of imminent danger to life or property during state of calamity**, to save and to prevent damage to or loss of life or property, or to restore vital public services;
- WHEREAS, it appearing that the price offered by **WINNABLE MARKETING CORPORATION** with business address located at Rizal Avenue Poblacion 22, Batangas City was found to be the most reasonable and advantageous to the City Government, if accepted;
