RECOMMENDING THE USE OF DIRECT CONTRACTING AS MODE OF PROCUREMENT FOR THE PURCHASE OF RADIO FREQUENCY IDENTIFICATION (RFID)

WHEREAS, Batangas City Government intends to procure Radio Frequency Identification (RFID) with approved Purchase Request (PR) Nos. 16839 charged under General Fund dated October 07, 2021 for use of various RP Vehicles assigned at City Environment and Natural Resources Office;

WHEREAS, the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of Section 50 of the IRR of RA 9184 (Direct Contracting) as per approved authority. Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, **Direct Contracting**, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained;

WHEREAS, it appearing that the price offered by **SMC SKYWAY CORPORATION** with business address located at St. Francis Street, Ortigas Center, Wack-Wack Greenhills, Mandaluyong City was found to be the most reasonable and advantageous to the City Government, if accepted;
