"BAC RESOLUTION NO. 2022 - 548

RECOMMENDING AWARD OF CONTRACT FOR THE ROOM ACCOMMODATION AND MEALS THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY CITY PLANNING AND DEVELOPMENT OFFICE, BATANGAS CITY

WHEREAS, the Batangas City Government intends to procure Room Accommodation and Meals with an Obligated Purchase Request No. 200-2022-09-011246 charged under General Fund dated September 29, 2022 with an Approved Budget for the Contract (ABC) amounting to One Hundred Twenty Four Thousand Eight Hundred Pesos (Php 124,800.00) for the conduct of Meeting, Training and Seminar of the Council for the Protection of Children as requested by City Planning and Development Office;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;

WHEREAS, on October 06, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotation (RFQ's) thru the Philippine Government Electronic Procurement System (Philgeps) for the procurement of the above mentioned project;

WHEREAS, before the deadline of submission of quotation, only SPLASH MOUNTAIN RESORT with business address located at Brgy. Lalakay, Los Banos, Laguna submitted its quotation;

WHEREAS, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned suppliers sufficiently complied with all the requirements needed which resulted to the following:
