

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF OXYGEN CONCENTRATOR AS REQUESTED BY CITY HEALTH OFFICE/BCIMT-MEDICAL RESPONSE TEAM

WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and **instill health consciousness among them;**

WHEREAS, as per IATF Resolution, Batangas City is still under the General Community Quarantine with heightened restrictions;

WHEREAS, the Approved Purchase Request No. 16498 charged under General Fund for the **Supply and Delivery of Ten (10) units Oxygen Concentrator amounting to Seven Hundred Thousand Pesos (Php700,000.00)** as requested by City Health Office/BCIMT-Medical Response Team was indorsed to the Bids and Awards Committee (BAC), to be used for the patients confined at the Temporary Health/Isolation Facilities of the City Government;

WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Negotiated Procurement-Emergency Cases) **in case of imminent danger to life or property during state of calamity**, to save and to prevent damage to or loss of life or property, or to restore vital public services;

WHEREAS, it appearing that the price offered by **JAYDEE CARE MARKETING** with business address located at Banaba South, Batangas City was found to be the most reasonable and advantageous to the City Government, if accepted;


