RECOMMENDING AWARD OF CONTRACT FOR THE RESCUE DIVING FEE THROUGH NEGOTIATED PROCUREMENT (SMALL VALUE PROCUREMENT) AS REQUESTED BY CITY DISASTER RISK REDUCTION AND MANAGEMENT OFFICE, BATANGAS CITY

WHEREAS, the Batangas City Government intends to procure Rescue Diving Training Fee with an Obligated Purchase Request No. 200-2022-08-009652 charged under General Fund dated August 24, 2022 with an Approved Budget for the Contract (ABC) amounting to Two Hundred Ninety Nine Thousand Six Hundred Forty Four Pesos and 80/100 (Php 299,644.80) for the conduct of Rescue Diving Training (Scuba Diving) as requested by City Disaster Risk Reduction and Management Office;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Negotiated Procurement-Small Value Procurement) citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR of RA 9184;

WHEREAS, on October 07, 2022, the Bids and Awards Committee-Secretariat/TWG for the Procurement of Goods and Services sent Request for Quotation (RFQ's) thru the Philippine Government Electronic Procurement System (Philgeps) for the procurement of the above mentioned project;

WHEREAS, before the deadline of submission of quotation, only BALAYAN BAY BOAT INC. with business address located at <u>Brgy. Poblacion, San Luis, Batangas</u> submitted its quotation;

WHEREAS, upon careful review and evaluation of the requirements submitted, it was found out that the aforementioned supplier sufficiently complied with all the requirements needed which resulted to the following:
