RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE RENTAL OF TEMPORARY HEALTH/ISOLATION FACILITY OF BATANGAS CITY GOVERNMENT

WHEREAS, the Batangas City Government intends to procure the Rental of Temporary Health/Isolation Facility with an Obligated Purchase Request No. 200-2021-10-010234 dated October 20, 2021 with Approved Budget for the Contract (ABC) amounting to Six Hundred Thousand Pesos (Php600,000.00);

WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and **instill health consciousness among them**;

WHEREAS, Batangas City, under the Community Alert Level II is still experiencing PANDEMIC due to the continuing spread of Corona Virus, thus, there is an utmost need for Batangas City and its people for health facilities that will accommodate PUMs, PUIs and COVID-19 positive patients;

WHEREAS, President Rodrigo R. Duterte issued Proclamation No. 922 s. 2020 declaring a State of Public Health Emergency throughout the Philippines in view of COVID-19. Under P.P. No. 922, the spread of COVID-19 was considered as an emergency that threatens national security. This declaration capacitated Local Government Units (LGUs) to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of COVID-19, as well as to mitigate its effect and impact to the community;

WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) in case of imminent danger to life or property during state of calamity, **to save and to prevent damage to or loss of life or property**, or to restore vital public services;

WHEREAS, it appearing that the price offered by **EMMANUEL SJB DEVELOPMENT CORPORATION (ASIATEL INN AND ARKO GRILL RESTAURANT)** with business address located at Soro soro Karsada, Batangas City was found to be reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HoPE for the APPROVAL of the AWARD and ACCEPT the offer made by **EMMANUEL SJB DEVELOPMENT CORPORATION (ASIATEL INN AND ARKO GRILL RESTAURANT)** in the grand total amount of **P600,000.00** to wit:


