"BAC RESOLUTION NO. 7021-582

RECOMMENDING THE USE OF DIRECT CONTRACTING AS MODE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF FRESH MILK AND FRESH MILK-CHOCO AS REQUESTED BY THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE

WHEREAS, the Batangas City Government intends to procure Fresh Milk and Fresh Milk-Choco with an Obligated Purchase Request No. 200-2021-10-010365 charged under General Fund dated October 22, 2021 with an Approved Budget for the Contract (ABC) amounting to Ninety Seven Thousand Five Hundred Pesos (Php97,500.00) as requested by City Social Welfare and Development Office.

WHEREAS, Section 6 of GPPB's Resolution No. 06-2020 dated April 6, 2020 states that to ensure the availability of food for all sectors, Procuring Entities are encourage to directly purchase agricultural products from local farmers or farmers' associations or cooperatives;

WHEREAS, the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of Section 50 of the IRR of RA 9184 (Direct Contracting) as per approved authority. Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, **Direct Contracting**, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained;

WHEREAS, it appearing that the price offered by **SORO SORO IBABA DEVELOPMENT COOPERATIVE** with business address located at Soro soro Ibaba, Batangas City was found to be reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HOPE for the APPROVAL of the AWARD and ACCEPT the offer made by **SORO SORO IBABA DEVELOPMENT COOPERATIVE** in the grand total amount of **P97,500.00** to wit:
