

## "BAC RESOLUTION NO. 1621-575

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE HAULING, TRANSPORT, STORAGE, TREATMENT AND DISPOSAL OF MEDICAL TOXIC AND INFECTIOUS AND OTHER HAZARDOUS WASTE AND SUBSTANCES AS REQUESTED BY CITY ENVIRONMENT AND NATURAL RESOURCES OFFICE, BATANGAS CITY

WHEREAS, the Batangas City Government intends to procure Hauling, Transport, Storage, Treatment and Disposal of Medical Toxic and Infectious and Other Hazardous Waste and Substances with an Obligated Purchase Request No. 200-2021-10-010104 charged under General Fund dated October 22, 2021 with an Approved Budget for the Contract (ABC) amounting to Two Million One Hundred Thousand Pesos (Php2,100,000.00).

WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, President Rodrigo R. Duterte issued Proclamation No. 922 s. 2020 declaring a State of Public Health Emergency throughout the Phlippines in view of COVID-19. Under P.P. No. 922, the spread of COVID-19 was considered an emergency because it threatens national security. This declaration capacitated Local Government Units (LGUs) to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of COVID-19, as well as to mitigate its effect and impact to the community;

WHEREAS, the number of COVID-19 positive patients are still high, although gradually dwindling, toxic wastes generated by households, temporary isolation facilities, government vaccination hubs and health offices requires proper handling, disposal and management;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Negotiated Procurement - Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services:

WHEREAS, it appearing that the price offered by <u>PYROTECH SOLUTION AND INTEGRATED SERVICES</u>

<u>CORPORATION</u> with business address located at <u>Purok 5</u>, <u>Brgy. Saimsim, Calamba, Laguna</u> was found to be reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HOPE for the APPROVAL of the AWARD and ACCEPT the offer made by **PYROTECH SOLUTION AND INTEGRATED SERVICES CORPORATION** in the grand total amount of **P2,100,000.00** to wit:
