RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF GOODS AND COMMODITIES

WHEREAS, the Batangas City Government intends to procure Goods and Commodities with an Approved Purchase Request No. 16505 charged under General Fund dated October 20, 2021, with an Approved Budget for the Contract (ABC) amounting to Two Hundred Forty Nine Thousand Six Hundred Seventy Seven Pesos (Php249,677.00) as requested by City Social Welfare and Development Office to be distributed to COVID-19 positive patients and their families;

WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and **instill health consciousness among them**;

WHEREAS, President Rodrigo R. Duterte issued Proclamation No. 922 s. 2020 declaring a State of Public Health Emergency throughout the Philippines in view of COVID-19. Under P.P. No. 922, the spread of COVID-19 was considered an emergency because it threatens national security. This declaration capacitated Local Government Units (LGUs) to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of COVID-19, as well as to mitigate its effect and impact to the community;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;

WHEREAS, Negotiated Procurement under Emergency Cases may be resorted in case of imminent danger to life or property during a **state of calamity**, or when time is of the essence arising from **natural** or man-made calamities or other cases where immediate action is necessary **to prevent damage to or loss of life or property**, or to restore vital public services, infrastructure facilities and other public utilities;

WHEREAS, the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of RA 9184, under Section 53.2 (Negotiated Procurement-Emergency Cases) as per approved authority;


WHEREAS, it appearing that the price offered by **BATANGAS CITIMART SHOP-ON, INC.** with business address located at Rizal Avenue, Pob. 16, Batangas City was found to be reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to **RECOMMEND** to the HOPE for the **APPROVAL** of the **AWARD** and **ACCEPT** the offer made by **BATANGAS CITIMART SHOP-ON, INC.** in the grand total amount of **P195,766.00** to wit:




