

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE SUPPLY AND DELIVERY OF OXYGEN TANK WITH REGULATOR AS REQUESTED BY THE BATANGAS CITY INCIDENT MANAGEMENT TEAM

WHEREAS, the Batangas City Government intends to procure Forty (40) sets Oxygen Tank with an Obligated Purchase Request No. 200-2021-10-010608 charged under General Fund dated October 26, 2021 with an Approved Budget for the Contract (ABC) amounting to Five Hundred Ninety Nine Thousand Eight Hundred Pesos (Php599,800.00) as requested by the BCIMT-Medical Response Team to be used for the patients confined at the Temporary Health/Isolation Facilities of the City Government;

WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, President Rodrigo R. Duterte issued Proclamation No. 922 s. 2020 declaring a State of Public Health Emergency throughout the Phlippines in view of COVID-19. Under P.P. No. 922, the spread of COVID-19 was considered an emergency because it threatens national security. This declaration capacitated Local Government Units (LGUs) to immediately act to prevent loss of life, utilize appropriate resources to implement urgent and critical measures to contain or prevent the spread of COVID-19, as well as to mitigate its effect and impact to the community;

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained;

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Negotiated property, or to restore vital public services:

WHEREAS, it appearing that the price offered by <u>555 PHARMACY & CONVENIENCE STORE</u> with business address located at <u>Ilustre Ave.</u>, <u>District III</u>, <u>Lemery</u>, <u>Batangas</u> was found to be reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HOPE for the APPROVAL of the AWARD and ACCEPT the offer made by <u>555 PHARMACY & CONVENIENCE STORE</u> in the grand total amount of **P599,800.00** to wit:
