WHEREAS, the Batangas City Government intends to procure Subscription of Official Gazette with an Obligated Purchase Request 200-2022-03-002492 dated March 07, 2022 charged under General Fund with Approved Budget for the Contract (ABC) amounting to Seven Thousand Eight Hundred Pesos (Php7,800.00) as requested by City Civil Registrar's Office;
