**"BAC RESOLUTION NO. 2021, 332"**


- WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and **instill health consciousness among them**;

- WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services:
- WHEREAS, upon canvass, it appearing that the price offered by **EL FLAMINGO TRAVEL LODGE** with business address located at Soro soro Karsada, Batangas City was found to be the most reasonable and advantageous to the City Government, if accepted;


