- WHEREAS, the President issued Proclamation No. 1021 (s.2020) on September 16, 2020 extending the period of the State of Calamity throughout the Philippines until September 21, 2021;
- WHEREAS, as per IATF resolution, Batangas City is still under the General Community Quarantine until August 30, 2021;
- WHEREAS, Batangas City intends to procure for the Refilling of LPG Tanks with an approved Purchase Request (PR) No. 15990 charged under General Fund dated July 29, 2021 as requested by the Batangas City Incident Management Team-Logistics Section/Kitchen Brigade to be used in the preparation of food for the frontliners assigned at and Covid19 patients confined in different city government health facilities;
- WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services:
- WHEREAS, upon canvass of these goods, it appearing that the price offered by **RBC PETRON GASOLINE STATION** with business address located at Kumintang Ilaya, Batangas City was found to be the most reasonable and advantageous to the City Government, if accepted;
