- WHEREAS, as per IATF resolution, Batangas City is still under the General Community Quarantine until August 30, 2021;
- WHEREAS, the Approved Purchase Request (PR) No. 15389, charged under General Fund dated August 06, 2021 for the **Supply and Delivery of Instant Coffee and Assorted Biscuits for Covid19 patients confined at the Temporary Health/Isolation Facilities of Batangas City Government amounting to Thirty Five Thousand Six Hundred Forty Nine Pesos (Php35,649.00)** as requested by City Health Office/BCIMT-Medical Response Team was indorsed to the Bids and Awards Committee (BAC);
- WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services;
