"BAC RESOLUTION NO. 2021-336

- WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill **health consciousness among them**;
- WHEREAS, the President issued Proclamation No. 1021 s.2020 on September 16, 2020 extending the period of the State of Calamity throughout the Philippines until September 21, 2021 due to Corona Virus Disease 2019;
- WHEREAS, as per IATF, Batangas City is still under the General Community Quarantine (GCQ) until August 30, 2021;
- WHEREAS, the Approved Purchase Request (PR) No. 15579, charged under General Fund, for the ***Supply, Delivery and Printing of Fifty Five Thousand (55,000) pieces Vaccination Card as requested by the City Health Office amounting to Two Hundred Sixty One Thousand Two Hundred Fifty Pesos (Php261,250.00)*** was indorsed to the Bids and Awards Committee (BAC);
- WHEREAS, on February 26, 2021, the President signed Republic Act No. 11525 or the COVID-19 Vaccination Program Act of 2021, which seeks to address the adverse impact of COVID-19 through the procurement of safe and effective COVID-19 vaccines, including ancillary supplies and services;
- WHEREAS, Batangas City has started its COVID-19 vaccination program last April 2021 for the health workers and senior citizens of the city and still on going on other residents of Batangas City, hence the need for vaccination cards;
- WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services;
- WHEREAS, upon canvass of these goods, it appears that the price offered by **TATAO SHIRTS & GENERAL MERCHANDISE** with business address located at **15 P. Torres St., Lipa City** was found to be the most reasonable and advantageous to the City Government at this time, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND for the APPROVAL of the AWARD and ACCEPT the offer made by **TATAO SHIRTS & GENERAL MERCHANDISE** in the grand total amount of P247,500.00 to wit;






