- WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and **instill health consciousness among them;**
- WHEREAS, the President issued Proclamation No. 1021 s.2020 on September 16, 2020 extending the period of the State of Calamity throughout the Philippines until September 21, 2021 due to the rapid spread of Corona Virus Disease;
- WHEREAS, Batangas City, under the General Community Quarantine until July 31, 2021 is still experiencing PANDEMIC with a recent spike in the numbers affected by the Corona Virus, thus, there is an utmost need for Batangas City and its people for health facilities that will accommodate PUMs, PUIs and COVID-19 positive patients;
- WHEREAS, Batangas City intends to procure the Rental of Temporary Health/Isolation Facility with an approved Purchase Request (PR) No. 14897 charged under General Fund dated June 28, 2021;
- WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services:
- WHEREAS, upon canvass, it appearing that the price offered by **EL FLAMINGO TRAVEL LODGE** with business address located at Soro soro Karsada, Batangas City was found to be the most reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HoPE for the APPROVAL of the AWARD and ACCEPT the offer made by **EL FLAMINGO TRAVEL LODGE** in the grand total amount of **P620,000.00** to wit.


