"BAC RESOLUTION NO. 2021-300

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE <u>SUPPLY AND DELIVERY OF GOODS AND COMMODITIES</u>

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised implementing Rules and Regulations (IRR) of Ra 9184, otherwise known as the 'Government Procurement Reform Act' provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are timed Sources Biding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement, provided that the most advantageous price for the government will be obtained:

WHEREAS, Negotiated Procurement under Emergency Cases may be resorted in case of imment danger to life or property during a state of calamity, or when time is of the essence arising from natural or main-made calamities or other cases when immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastracture facilities and other public utilities.

WHEREAS, as per DOST-PHILVOCS, Taal Volcano is at Alert Level 3 (magmatic unrest) since July 1, 2021, which further recommends evacuation of all residents living in the entire Taal Volcano Island and barangays/municipalities around the Taal Lake shores;

WHEREAS, as of July 05, 2021, Batangas City hosts 93 evacuees from the Municipalities of Lemery, Agoncillo, Talisay, Taal, Laurel and San Nicolas needing accommodation, food and subsistence:

WHEREAS, the Approved Purchase Request (PR) No. 1503? charged under Trust Fund, for Kapply and Delivery of Goods and Commodities for the Toal Volcamo Fruption Evacues: as requested by the City Social Welfare and Developmen Office amounting to One Million Four Inturder Winety Nine Thousand Nine Hundred Eighty Pesos (Php.1499;880.00) was indicased to the Bids and Austica Committee [BAC]:

WHEREAS, the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of RA 9184, under Section 53.2 (Emergency Cases) as per approved authority:

WHEREAS, upon canvass, it appearing that the price offered by <u>SMARTBIZ TRADING & GENERAL MERCHANDISE</u> with business address located at <u>10 Buenafe St., Brgy.</u> <u>19. Batangas City</u> was found to be the most reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HoPE for the APPROVAL of the AWARD and ACCEPT the offer made by <u>SMARTBIZ TRADING & GENERAL</u> <u>MERCHANDISE</u> for the Rental of Heavy Equipment in the grand total amount of P1,499,680.00 to wit:
