- WHEREAS, as per announcement made by President Rodrigo Duterte on May 31, 2021, Batangas City is still under the General Community Quarantine until June 30, 2021
- WHEREAS, Batangas City intends to purchase Food Pack/Container with an approved Purchase Request (PR) No. 14891 charged under General Fund dated June 21, 2021 requested by Batangas City Incident Management Team-Logistics Section/Kitchen Brigade to be used in the food preparation for the frontliners and Covid19 patients confined in city government's temporary health/isolation facilities;
- WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services:
- WHEREAS, upon canvass of these goods, it appearing that the price offered by ERNMAR BIEN TRADING with business address located at Brgy. 21, Batangas City, was found to be the most reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND for the APPROVAL of the AWARD and ACCEPT the offer made by ERNMAR BIEN TRADING in the grand total amount of 500,000.00 to wit;
