WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the President issued Proclamation No. 1021 s.2020 on September 16, 2020 extending the period of the State of Calamity throughout the Philippines until September 21, 2021 due to Corona Virus Disease 2019;

WHEREAS, as per announcement made by President Rodrigo Duterte on May 31, 2021, Batangas City is still under the General Community Quarantine until June 30, 2021;

WHEREAS, the Approved Purchase Request (PR) No. 14394, charged under General Fund, for the Supply and Delivery of Purified Drinking Water for use in various Temporary Health/Isolation Facilities of Batangas City Government amounting to Two Hundred Eight Five Thousand Pesos (Php285,000.00) was indorsed to the Bids and Awards Committee (BAC);

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services;

WHEREAS, upon canvass, it appears that the price offered by <u>GAVE'S WATER REFILLING STATION</u> with business address located at <u>Gulod Labac, Batangas City</u> was found to be the most reasonable and advantageous to the City Government at this time, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND for the APPROVAL of the AWARD and ACCEPT the offer made by GAVE'S WATER REFILLING STATION in the grand total amount of P285.000.00 to wit:
