## "BAC RESOLUTION NO. 2021 - 239

## RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE RENTAL OF HEAVY EQUIPMENT AS REQUESTED BY CITY DISASTER RISK REDUCTION MANAGEMENT OFFICE, BATANGAS CITY

WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and Negotiated Procurement, provided that the most

advantageous price for the government will be obtained;

WHEREAS, Negotiated Procurement under Emergency Cases may be resorted in case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other cases where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastracture facilities and other public utilities:

WHEREAS, based on the assessment conducted by the Batangas City Disaster Risk Reduction Management Council and the recent model provided by DOST-NOAH, Batangas City is vulnerable to storm surge and flooding especially during typhoons and heavy rains;

WHEREAS, Batangas City previously experienced typhoons and heavy rains that caused widespread destruction and damages in the city and flooding in various barangays such as Pallocan West, Pallocan East, Libjo and other barangays in low-lying and flood prone area until this time;

WHEREAS, the Approved Purchase Request (PR) No. 15047 charged under Trust Fund, for the Rental of Heavy Equipment as requested by the City Disaster Risk Reduction Management Office amounting to One Million Nine Hundred Ninety Nine Thousand Seven Hundred Pesos (Php1,999,700.00) to be used in cleaning and clearing of various barangays as part of CDRRMO's preparedness and mitigation activities in preparation for heavy rainfalls and typhoons to prevent heavy flooding and widespread destruction in the city was indorsed to the Bids and Awards Committee (BAC);

the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of RA 9184, under Section 53.2 (Emergency Cases) as per approved authority;
