RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE <u>SUPPLY AND DELIVERY OF FOOD SUPPLIES FOR USE OF BATANGAS CITY</u> GOVERNMENT

WHEREAS,	Section 15 Article II of the 1987 Constitution states that the State shall protect and promote

WHEREAS, the President issued Proclamation No. 1021 (s.2020) on September 16, 2020 extending the period of the State of Calamity throughout the Philippines until September 21, 2021:

WHEREAS, as per IATF resolution, Batangas City is still under the General Community Quarantine until April 30, 2021;

WHEREAS, Batangas City Government intends to procure Food Supplies (Wet and Dry) charged under Trust Fund (Cash Advance) dated April 13, 2021 to be served for frontliners and Covid-19 patients currently confined in various Temporary Health Facilities of Batangas City Government as requested by BCIMT-Logistic Section/Kitchen Brigade:

WHEREAS, Batangas City, under the General Community Quarantine is still experiencing PANDEMIC with a recent spike in the numbers affected by the Corona Virus, thus, there is an utmost need to procure goods hereunder listed for the health and nourishment of patients confined at the Temporary Health/Isolation Facility and frontliners assigned in the conduct of Covid19 programs and activities:

WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services:
