- WHEREAS, the President issued Proclamation No. 1021 s.2020 on September 16, 2020 extending the period of the State of Calamity throughout the Philippines until September 21, 2021 due to Corona Virus Disease 2019;
- WHEREAS, as per IATF Resolution No. 113-A dated April 29, 2021, Batangas City is still under the General Community Quarantine until May 31, 2021;
- WHEREAS,
 Batangas City Government thru the City Health Office, intends to procure Antigen Test
 Kit with approved Purchase Request (PR) No. 14564 charged under Trust Fund dated
 May 05, 2021 for a faster and accurate Covid19 test result;
- WHEREAS, as per records, it appearing that there is a sudden increase in the number of COVID19 positive cases in Batangas City which started late last year;
- WHEREAS, there is an urgent need in the procurement of Antigen Kits for the conduct of ANTIGEN SWAB TESTING at a much faster phase with accurate result to residents of Batangas City so as to prevent the spreading of COVID19 virus and to detect those that are infected;
- WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services;
- WHEREAS, upon canvass of these goods, it appears that the price offered by <u>VG & GE TRADING</u>

 <u>DIAGNOSTIC, INC</u> with business address located at <u>Lot 21 Blk 10 Levitown, Marawoy,</u>

 <u>Lipa City</u> was found to be the most reasonable and advantageous to the City

 Government at this time, if accepted;
