- WHEREAS, the President issued Proclamation No. 1021 s.2020 on September 16, 2020 extending the period of the State of Calamity throughout the Philippines until September 21, 2021 due to Corona Virus Disease 2019;
- WHEREAS, as per IATF Resolution No. 113-A dated April 29, 2021, Batangas City is still under the General Community Quarantine until May 31, 2021;
- WHEREAS, there is a considerable increase in the number of persons infected by the CORONA VIRUS DISEASE in Batangas City, thus there is an immediate need to purchase these materials for use BCIMT-Sanitation Strike Team with an approved Purchase Request (PR) No. 14730 charged under General Fund dated May 5, 2021 as requested by City Environment and Natural Resources Office to be used in the disinfection of facilities, government offices and barangays of Batangas City;
- WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services:
