"BAC RESOLUTION NO. 2021-12"


- WHEREAS, Section 15 Article II of the 1987 Constitution states that the State shall protect and promote the right to health of the people and instill health consciousness among them;
- WHEREAS, the President issued Proclamation No. 1021 (s.2020) on September 16, 2020 extending the period of the State of Calamity throughout the Philippines until September 21, 2021;
- WHEREAS, Batangas City is under State of Calamity due to Corona Virus Pandemic by virtue of City Mayor Beverley Rose A. Dimacuha's declaration last March 13, 2020;
- WHEREAS, as per IATF resolution, Batangas City is still under the General Community Quarantine until March 31, 2021;
- WHEREAS, Batangas City intends to procure the Rental of Motor Vehicles with an approved Purchase Request (PR) No. 13919 charged under Trust Fund dated March 12, 2021 as requested by Batangas City Incident Management Team to be used by the EBD Monitoring Group for Contact Tracing, monitoring of different establishments and disseminating of information with regard to the Health Safety Protocol of the City Government in response to the fight against Covid19;
- WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) citing the utmost need to save and to prevent damage to or loss of life or property, or to restore vital public services:
- WHEREAS, upon canvass of these goods, it appearing that the price offered by D. DIMAANDAL CAR CARE CENTER with business address located at Kumintang Ibaba, Batangas City was found to be the most reasonable and advantageous to the City Government, if accepted;






