the Approved Purchase Request (PR) No. 16611 charged under Trust Fund dated September 17, 2021 for the Rental of Temporary Health/Isolation Facility amounting to One Million Five Hundred Forty Nine Thousand Eight Hundred Forty Five (Php1,549,845.00) as requested by the Batangas City Government was indorsed to the Bids and Awards Committee (BAC);

WHEREAS,

Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) in case of imminent danger to life or property during state of calamity, to save and to prevent damage to or loss of life or property, or to restore vital public services;
