"BAC RESOLUTION NO. 2021-462"

- WHEREAS, Section 15 Article II of the 1987 Constitution avers that the State shall protect and promote the right to health of the people and instill health consciousness among them;
- WHEREAS, Batangas City, under the General Community Quarantine is still experiencing PANDEMIC due to the spread of Corona Virus, thus, there is an utmost need for Batangas City and its people for health facilities that will accommodate PUMs, PUIs and COVID-19 positive patients;
- WHEREAS, the Approved Purchase Request (PR) No. 16608 charged under General Fund dated September 20, 2021 for the **Rental of Temporary Health/Isolation Facility amounting to Six Hundred Twenty Thousand Pesos (Php620,000.00)** as requested by the Batangas City Government was indorsed to the Bids and Awards Committee (BAC);
- WHEREAS, Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" with its 2016 revised Implementing Rules and Regulations (IRR) took effect on October 26, 2016 states that the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the IRR of RA 9184 (Emergency Cases) in case of imminent danger to life or property during state of calamity, **to save and to prevent damage to or loss of life or property**, or to restore vital public services;
- WHEREAS, it appearing that the price offered by **EMMANUEL SJB DEVELOPMENT CORPORATION (ASIATEL INN AND ARKO GRILL RESTAURANT)** with business address located at Soro soro Karsada, Batangas City was found to be reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HoPE for the APPROVAL of the AWARD and ACCEPT the offer made by **EMMANUEL SJB DEVELOPMENT CORPORATION (ASIATEL INN AND ARKO GRILL RESTAURANT)** in the grand total amount of **P620,000.00** to wit:
