"BAC RESOLUTION NO. 2021-419

RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT-EMERGENCY CASES AS MODE OF PROCUREMENT FOR THE TERMITE AND RAT CONTROL SERVICES AS REQUESTED BY GENERAL SERVICES DEPARTMENT

- WHEREAS, Section 48, Rule XVI Alternative Methods of Procurement of the Revised Implementing Rules and Regulations (IRR) of RA 9184, otherwise known as the "Government Procurement Reform Act" provides that in order to promote economy and efficiency, the procuring entity may resort to any of the alternative methods of procurement which are Limited Source Bidding, Direct Contracting, Repeat Order, Shopping and **Negotiated Procurement**, provided that the most advantageous price for the government will be obtained;
- WHEREAS, Negotiated Procurement under Emergency Cases may be resorted in case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from **natural** or man-made calamities or other cases where immediate action is necessary to **prevent damage to or loss of life or property**, or to restore vital public services, infrastructure facilities and other public utilities;
- WHEREAS, the Approved Purchase Request (PR) No. 16281 charged under General Fund, for the ***Procurement of Termite and Rat Control Services as requested by General Services Department amounting to Fifty Thousand Pesos (Php50,000.00)*** was indorsed to the Bids and Awards Committee (BAC);
- WHEREAS, aside from the significant damages in the whole building of the Batangas City Warehouse caused by termites and rats, these pests are threatening to the supplies, materials, equipment and other properties of the city stored/kept in the building, hence, the procurement;
- WHEREAS, the Bids and Awards Committee is authorized to resort to Alternative Mode of Procurement in accordance with the provisions of RA 9184, under Section 53.2 (Emergency Cases) as per approved authority;
- WHEREAS, upon canvass, it appearing that the price offered by **MAPECON PHILIPPINES INC.** with business address located at **251 National Highway, Brgy. Aguila, San Jose, Batangas** was found to be the most reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND to the HoPE for the APPROVAL of the AWARD and ACCEPT the offer made by **MAPECON PHILIPPINES INC.** for the Procurement of Termite and Rat Control Services in the grand total amount of P50,000.00 to wit:
