- WHEREAS, The Batangas City Government intends to procure various books for use of Colegio ng Lungsod ng Batangas' Library with an approved Purchase Request No. 15629 charged under General Fund dated July 14, 2021 amounting to Thirty One Thousand Nine Hundred Two Pesos (Php31,902.00);
- WHEREAS, there is an utmost need to purchase the books hereunder listed which will be used as additional sources of information for students and instructional materials for the professors of Colegio ng Lungsod ng Batangas;
- WHEREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.9 of the IRR of RA 9184 (Small Value Procurement) citing that the amount of goods being procured does not exceed the threshold prescribed by the IRR and does not fall under Shopping in Section 52 of the IRR;
- WHEREAS, upon canvass of these goods, it appears that the price offered by **REX BOOK STORE** with business address located at **84 P. Florentino St., St. Mesa Hts., Quezon City** was found to be the most reasonable and advantageous to the City Government, if accepted;

NOW, THEREFORE, RESOLVED as it is Hereby Resolved, to RECOMMEND for the APPROVAL of the AWARD and ACCEPT the offer made by **REX BOOK STORE**, in the grand total amount of P31,889.25 to wit:




