The Batangas City Government now invites bids for the above-described infrastructure projects. The description of the eligible bidders is contained in the Bidding Documents, particularly in the Instruction to Bidders. Only prospective bidders who bought the bidding documents can attend the pre-bid conference

Bidding will be conducted through open competitive bidding procedures using the non-discretionary "pass/fail" criterion as specified in the 2016 Implementing Rules and Regulations of RA 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorship, cooperatives and partnership organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to the citizens of the Philippines.



Bids will be opened in the presence of the bidder's representative who choose to attend at the address stated in the Bidding documents. Late bids will not be accepted.

The Batangas Government assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.

The Batangas Government reserves the right to reject any and all bids, declare failure of bidding, or not award the contract any time prior to the contract award in accordance with Sec 41 of RA 9184 and its IRR without thereby incurring any liability to the affected bidder or bidders.
